#### APPLICATION RANGE:

Quintab Clean is an ultra-wetting highly active maintenance cleaner for strongly water-repellent elastic floorings. It cleans without residues and streak-free. It optimises the maintenance cleaning in 1 and 2-stage mopping processes. Suitable for use in automatic cleaning units. It has been especially developed for the cleaning of floorings that have been PU-annealed ex works. Removes the most diverse forms of soiling during the daily maintenance cleaning, e.g. oils and grease in addition to lime residue.

#### INSTRUCTIONS FOR USE AND DOSAGE:

Place the Quintab Clean in its water-soluble foil in a bucket/automatic cleaning unit and fill up with water. (Caution: do not tear the foil open). The cleaning solution is ready for use after approx. 5 minutes. The tab is suitable for use with 10 l of water. In the event of heavy soiling, spray over surface floor with machine. Store in a dry place!
